2025 Seasonal Camping Rules and Regulations

The Town of Fort Qu'Appelle reserves the right to refuse any applications.

All bookings must be done online and paid in full by credit card. Administration and credit card processing fees are added to the seasonal camping price.

If you do not sign and return these rules and regulations within ten days of receipt, your money will be refunded, and you will not be allowed to camp this year at the Fort Qu'Appelle Campground. Email completed rules and regulations to: forttown@sasktel.net

Further failure to comply with all permit conditions/regulations, Public Health Orders and could result in eviction, loss of the camping site for the season and/or any paid fees. The Town of Fort Qu'Appelle reserves the right to make changes without notice.

2025 Seasonal General Information, Conditions and Regulations

- Seasonal campsites are available from May 11, 2025, up to and including September 22, 2025. Trailers can be spotted on your designated site starting May 7, 2025.
- Campsites are on a first-come first-served basis.
- Applicants can only book for one campsite. The site is for the name on this application only, extended family does not apply.
- Campground services may be reduced prior to Victoria Day weekend and after Labour Day weekend.
- Absolutely no elm wood allowed no exceptions. If elm wood is found, it will result in immediate eviction.
- Only one camping unit (including tents) is allowed per site. Mobile homes and bunkhouse are prohibited. All units must be maintained so as not to detract from the park setting. Length restrictions apply. All camping equipment must be contained within the campsite.
- One small tent per site for accommodating dependent children and one screened tent
 for meal purposes may be allowed with prior approval from the Campground Manager
 or designate depending on the size of the campsite. Camper shall maintain the site
 (including cutting grass) and unit in a condition acceptable to the Campground Manager.
- Visitors may not share the same campsite, unless prior arrangements have been made with the Campground Manager.
- Only two vehicles allowed per site at any time. Any vehicle detached from unit is considered one of the two vehicles. One watercraft is allowed per site. Visitors may park vehicles in the parking lot. No off-road vehicles allowed.
- One picnic table and fire pit will be supplied per campsite.



- Major appliances are restricted to those fixed to the unit or contained within its original structure. No exceptions, if any are found you will be evicted immediately.
- All water must be contained and disposed of at the trailer disposal site. The dumping of greywater on the ground is prohibited, failure to comply will result in immediate eviction.
- Lights are restricted to a maximum of one string per site and must be CSA approved.
- All units, other than tents and truck campers, shall be legally registered and display a current and valid license plate at all times.
- Permit holders shall not rent, sell, sublet, assign or otherwise transfer seasonal sites.
 Fees will be refunded as per the cancellation policy.
- All units must be movable upon 24-hour notice. At the end of the camping season, the
 unit and all personal property must be removed, failure to comply will result in a
 penalty.
- The permit holder, including family members and/or guests, shall comply at all times
 with permit conditions and regulations. The permit holder is ultimately responsible for
 any noise, inappropriate behavior or conduct of any persons at their designated site.
- Pets must be kept on a leash and attended to at all times. Pet litter is to be cleaned up immediately by pet owner/permit holder. Pets are not permitted on public structures including beach, swimming area or the splash park.
- The use of tarps for protection from the elements will be accommodated. Tarps cannot create safety concerns within the campground. Cutting, defacing, nailing or screwing items to any tree in the park is strictly prohibited.
- Hot tubs are prohibited in the campground. No one is allowed to tamper with panel boxes or change breakers.
- Seasonal campers are expected to use their site regularly.
- The Campground Manger must be notified if the unit is to be removed from the seasonal site for any time period. The Town of Fort Qu'Appelle reserves the right to assign any vacated site to another camper for the vacated period. Twenty-four (24) hours is required when returning to a seasonal site.
- No open fires. Fires are allowed in designated fire pits and barbeques only.
- Quiet time 11:00 P.M. until 6:00 A.M. Visitors must leave the campground by 11:00 P.M. Failure to comply may result in eviction.
- Speed limit is 15 km/hr., as posted.
