

**BYLAW 04-2025**

**A BYLAW OF THE TOWN OF FORT QU'APPELLE TO ESTABLISH AND REGULATE COLLECTION AND DISPOSAL OF WASTE.**

The Council of the Town of Fort Qu'Appelle in the Province of Saskatchewan enacts as follows:

1. In this bylaw unless the context otherwise requires:
  - a) "Commercial" means small commercial businesses that produces a maximum of two 95-gallon carts of garbage bi-weekly, does not include large producers of weekly garbage that exceed two 95-gallon carts per week;
  - b) "Dwelling Unit" means –
    - i. a single-family home;
    - ii. each individual household with separate living accommodations within a single-family home, multi-dwelling unit buildings with separate living accommodations, basement suites, duplexes, triplexes, fourplexes, and/or each unit within a multi-family building that has separate dwelling units. Sharing laundry facilities within, but not limited to, a single-family dwelling, multi-dwelling unit, apartments, or condos does not consolidate the separated households into one household within the building. Renting of a bedroom room in a single-family home that shares laundry, kitchen, and bathroom is not considered a separate dwelling unit;
  - c) "Fees" means the fees charged for solid waste pickup and disposal and recycling pickup and disposal as described in Schedule A as attached to this bylaw;
  - d) "Garbage" means putrescible animal and vegetable wastes resulting from the handling, preparation, cooking and consumption of food, other discarded materials resulting from domestic, industrial, commercial or agricultural activities, does not include commercial cooking grease or oil, animal carcasses, recyclable materials or rubbish;
  - e) "Light Commercial" means use in non-industrial, non-warehouse, non-common area and non-heavy foot traffic areas such as use in specialty retail, and medical/professional offices;
  - f) "Putrescible" means capable of becoming odorous;

- g) "Recyclable" means cardboard, boxboard, office paper, newsprint, junk mail, magazines, catalogues, plastic containers, plastic milk jugs, milk and juice cartons, tin, aluminum, and glass. All plastic containers or cartons must display a recycling symbol. Recyclable does not include clamshell containers, lightbulbs, plastic bags and stretch wrap, wood and metal scrap, diapers, Styrofoam and plastic utensils, hoses and rubber items, toys and clothing, or food and garbage.
  - h) "Rubbish" means non-putrescible wastes, consisting of both combustible and non-combustible wastes such as construction or demolition materials, paint, propane tanks or smaller camping fuel canisters, car batteries, mattresses, abandoned automobiles, tires, wood, metal scrap, Styrofoam, hoses and rubber items, glass such as windshields, bedding, crockery and comparable materials.
2. Solid waste in the Town of Fort Qu'Appelle shall be removed to the North Valley Waste Management Authority Waste disposal ground by:
    - i. an employee of the Council; or
    - ii. a person who has contracted with the council for that purpose; or
    - iii. as otherwise determined by resolution or bylaw of Council.
  3. Recycling material in the Town of Fort Qu'Appelle shall be removed to Crown shredding in Regina SK.
  4. Garbage and recycling carts will be brought to the street at the front of the property for pick up by 7:00 am the day of garbage pickup and will removed from the street no later than 48 hours after garbage pickup. Requests for alternate pickup locations will be considered by the CAO and the Public Works Foreman only when front property pickup is absolutely inaccessible, except for light commercial and commercial locations. Garbage bags or any other materials placed outside the cart will not be picked up.
  5. Each dwelling unit must have a 95-gallon cart that can be picked up by the contractor's equipment and each dwelling unit is allowed a maximum of two 95-gallon carts and will be charged the standard fee for each cart. Garbage pickup for dwelling units is once bi-weekly. Commercial businesses, as defined in this bylaw, can apply for garbage pickup up to a maximum of two 95-gallon carts and will be charged the standard fee for each cart.
  6. It is the dwelling unit's or commercial business's responsibility to keep the garbage cart area clean and rodent free.
  7. Grass clippings must be bagged and placed in the garbage cart.
  8. Placing recyclable items or rubbish items in garbage carts is prohibited and the Town will refuse to pick up the cart or carts until the items are removed by the dwelling unit. Continual dumping of recyclable items or rubbish items in garbage carts is a violation of the provisions in this bylaw and will be fined \$100.00 for each offense.

## ILLEGAL DUMPING

9. Garbage, rubbish, grass clippings, and recyclables that are brought in from another community is strictly prohibited. Any person dumping garbage, rubbish, grass clippings, or recyclables on public or private property that accumulated from a property in another community is in violation of the provisions of this bylaw and will be fined \$500.00 for the first offence and \$1,000.00 for each subsequent offence thereafter. Travelling tourists that dump garbage in public receptacles are exempt.
10. Unless otherwise indicated in this bylaw, failure to comply with any provisions of this bylaw will be fined \$100.00 per each offense.
11. Bylaw 12-2022 are hereby repealed, with this Bylaw effective on date of adoption.
